- LARGE ANIMAL CATEGORY MUST HAVE EDUCATIONAL CLASS AND UP TO DATE BCQA TRAINING-CALL TO SEE IF YOURS IS UP TO DATE
- ALL PARTICIPANTS MUST HAVE EDUCATIONAL CLASS TO RECEIVE REIMBURSEMENT CHECK. BCQA IS NOT ELIGIBLE FOR EDUCATIONAL UNLESS DOING A CATEGORY OTHER THAN LARGE ANIMAL.
